COVID-19 Daily Update 5-1-20

RESTARTING MAINE'S ECONOMY | STAY SAFER AT HOME

We are getting a dizzying amount of information and instruction on what to do and how to do it in this ever-changing world of Covid-19. After studying the plan to begin reopening the economy **maine.gov/covid19/restartingmaine** and the "Stay Safer at Home" Executive Order #49 that made it law **townofvinalhaven.org/sites/vinalhavenme/files/uploads/an_order_to_stay_safer_at_home.pdf**, we offer here a summary of what we are expected to do.

Stage 1, May Plan for RESTARTING MAINE'S ECONOMY

Governor Mills outlined the plan on Tuesday, April 28, and offered some details of what might happen in four stages. Only the first stage of the opening has been made "official", and this went into effect today. It gives guidance on what hair salons, car dealerships and some others must do to safely reopen their doors. It also requires that we wear face coverings when in an area where we are unable to maintain social distancing. The other three stages are outlined as possibilities, to give businesses some time to begin rethinking how their operations will need to be run.

The first three stages all require self-quarantining for two weeks of people who arrive from out of state, making it impossible for most out-of-staters to come for

a vacation. It is possible, although difficult, for our seasonal friends to come here. We are working with our contractors and property managers to develop some guidelines on how this can work safely. Contractors report that the people inquiring about returning are diligent and respectful, and want to be sure their return does no harm, either by bringing the virus or by stressing the services that are already struggling with the way they have to do business. There will be more information on this issue next week.

While progression through the stages is planned month-by-month, decisions by the Governor on implementation of the later stages will be determined by public health metrics. Progress may also change based on virus trends, testing or treatment breakthroughs, or identification of new, safe ways of doing business.
