Motion by Jessica MacDonald Martin to write a letter to US Army Corps of Engineers requesting an Environmental Impact Statement or a complete Environmental Assessment regarding the proposed dredging for Searsport Harbor. Second by Eric Gasperini. Vote 3-1-0. Jack Olson voted no. Motion carried.

Arch Gillies and Steve Miller made presentations about the proposed dredging and left some materials with the Board of Selectmen.

b. Approve and sign Notice of Determination of Presumption of Abandonment – "Enion Road"

Motion by Jack Olson to approve and sign the Notice of Determination of Presumption of Abandonment for the road known as "Enion Road". Second by Eric Gasperini. Vote 4-0-0. Motion carried.

- **a.** Vinalhaven Financial Audit Report Audit report was presented. There were no questions.
- **b.** Land Use Ordinance Amendments Eric Gasperini asked for this item to be place on the agenda. Gigi Baas, Planning Commission Chair asked why the Board of Selectmen are considering this change to the Vinalhaven Land Use Ordinance. Jack stated that with a 12 foot pier, you can't get four rows of traps. The 16 feet give you the ability to stack four rows of traps. Sixteen feet is also a standard length of lumber. Gigi also stated that this amendment will have to be reviewed by the Department of Environmental Protection division of Shoreland Zoning. Gigi went on the say that an amendment should not be reactive. The Planning Commission is meeting February 19th at 7:00 p.m. They will make sure this amendment is consistent with other parts of the Land Use Ordinance.

Auto excise tax is 7.97% above the previous year and 27.8% above budgeted revenue.

Tax Acquired Property – The Town foreclosed on the property owned by Shawn Eaton at Map 9, Lot 21D. The Selectmen asked the Town Manager to write a letter to Mr. Eaton giving him 30 days to pay all that is owed on the property or the Town will proceed with the sale of the property.
